# **COVID-19 Something Is Not Right!**

### **CRIMINAL INTENT, DEATH, & COVER-UP**

On December 2nd, 2021 the Food and Drug Administration (FDA) went to court to block the release of documents requested through the U.S. Freedom of Information Act (FOIA). The FDA wanted to keep these Pfizer pharmaceutical company documents hidden from the public for 55 years.

The documents pertained to the <u>Pfizer</u> prelaunch COVID-19 human vaccine trial, as well as the results for the first 3 months of the national vaccine program in the United States, and more.

The court ruled that while some of the most sensitive documents can be kept secret from the public for 20 years, several of the papers requested had to be released immediately. The FDA has since asked that it have a total of 75 years before the FOIA request is completed.

One of the <u>documents</u> recently released shows that during the pre-launch human trial, <u>1 in 17 participants died from the shot</u>. There were other details about injury, types of illnesses triggered by the injections, etc., but the death rate is what is most shocking. And it gets worse.

As we all know, <u>Pfizer</u> went ahead with their global vaccine program with the endorse-

ment of the FDA, despite both organizations knowing that the Pfizer shot was deadlier than any other vaccine in history, and magnitudes more lethal than what is being called COVID-19.

Another document that the court ordered released shows that in the first 90 days of the Pfizer vaccine rollout, an average of 13 people a day died from the shot in the USA (1200 vaccine deaths in total). During this same timeframe there were also over 150,000 side-effects, many of them quite serious.

What is also deeply concerning is that Pfizer (and all the other vaccine providers) indicated back in the first quarter of this year that the most concerning side-effects from their pre-launch clinical trials were a sore arm, fatigue, headache, and muscle soreness.

One of the more appalling lies used by mainstream media has been telling the public that the risk reduction (of infection) by getting a COVID-19 vaccine is as much as 95%. This is a lie. 


The censorship is so extreme that the <u>UN is</u> now taking down private websites at the domain level.

#### THE ISSUE OF THE UNVACCINATED

An important part of the evolving mainstream narrative by governments and corporate media includes turning those who are vaccinated against those who are not.

Wherever there is mainstream coverage of COVID-19, the message is that the recent increase in cases and/or hospitalizations are from the 'unvaxxed'. Interestingly, this is exactly the opposite of what government statistics and medical journals tell us. Unfortunately, most people don't check the sources. Instead, they trust the corrupt media and repeat what they read or hear without double-checking the information, thus deceiving themselves and others.

It varies slightly per jurisdiction, but the numbers are clear. Between 70% and 99% of people currently being hospitalized are vaccinated. Even Fauci admits that there is an "uptick" in the vaccinated being hospitalized but he says this is because they have not received their booster shot.



In some jurisdictions, 100% of those hospitalized are vaccinated. This is because in those regions only vaccinated people are allowed to access hospitals, including the ER.




### VACCINE ADVERSE EVENTS DATABASES

In 1990 the United States government created The Vaccine Adverse Events
Registry System (VAERS). This is a voluntary reporting system for vaccine injury or death that was put in place to comply with the 1986 National Childhood Vaccine Injury Act. This act acknowledged that vaccines are "unavoidably unsafe" and as a result exempted all vaccine manufactures from liability for their products.

The VAERS and its website are challenging to navigate. The more user-friendly <a href="OpenVAERS Project website">OpenVAERS Project website</a> allows browsing and searching of the VAERS reports without the need to compose an advanced search (more advanced searches can be done at medalerts.org).

When we check VAERS, the number of injuries and deaths attributed to the COVID-19 shot in 2021, that have been accepted into this U.S. database, reflects a catastrophic picture. As of December 10<sup>th</sup>, 2021, the VAERS records a total of 20,726 people who have died as a result of getting the COVID-19 shot in the United States.



Just to put that in context, the second worst year since the U.S. government started recording vaccine adverse event data over 30 years ago was 2019. In 2019, a total of 605 people died from all vaccinations. That's 20,726 vs. 605, and we still have 3 weeks left in 2021.

A logical question at this point is, how accurate is the reporting of vaccine injury or death to the VAERS database? Let's take a look. A Harvard Vaccine Injury Study conducted from 2007 to 2010, clarifies that there is less than 1% reporting rate for VAERS. "Less than 1%". This means that the number of people who have actually died as a result of getting the COVID-19

injections, so far, is more likely to be over 2 million people in the United States alone.

There are other VAERS-like systems around the world, such as in Europe (EudraVigilance), the UK (Yellow Card), and the WHO (VigiBase). Each of these database systems show the same COVID-19 vaccine trends, and in some cases the numbers of deaths per capita are even higher than in the United States (Europe, the UK, WHO).

### WHAT DOES THE RESEARCH SAY?

We know what you are thinking. Surely by now there must be sound clinical research that clarifies the efficacy of the COVID-19 vaccines. Yes, such research does exist, and it does shed more light on the current situation:





There has also been independent research into what exactly is in the vaccines. This was first conducted by Dr. Pablo Campra, Ph.D. of the (public) University of Almeria, in Spain. His technical report indicates that graphene oxide is present in large quantities in the manufacturer's sealed vaccine vials. Graphene oxide and hydroxide are highly toxic and damaging to human health.

This research has been replicated by other researchers including <u>Dr. Andreas Kalcker Ph.D.</u>, a <u>German biophysical researcher living in Switzerland</u>, and by <u>Dr. Robert Young N.D.</u>, a microbiologist from the <u>United States</u>, who also found <u>exotic parasites and stainless steel in the "vaccine" vials.</u>

Other scientists have also reported finding graphene oxide and other extremely concerning biological and non-biological particles, as well as very strange parasites, in the contents of the COVID-19 injections. The latter includes organisms called hydras (which keep restructuring, reconstituting and reproducing even after being cut up or blended up in the laboratory).

At least 35 independent teams of scientists around the world have researched the different brands of the COVID-19 vaccines. Graphene, as well as a range of other elements not listed on the vaccine insert sheet were found in all the vaccine vials tested.

#### **EXEMPT FROM LIABILITY & THE SHOT**


